### Did you know that Newfield Exploration offers payment by Direct Deposit via ACH?

Newfield Exploration also partners with Oildex to provide an Owner Relations Online System where you may obtain your Direct Deposit remittance detail, FREE of charge, via a SECURE internet website 24 hours a day.

Oildex will mail you a letter containing your temporary login information. However, if you wish to login prior to receiving the letter, please call Oildex at 1-800-318-7850. You must have your Newfield owner number available when calling Oildex. Your owner number can be found both on the face of your most recent revenue check and at the top of each page of check detail.

You can access both your current and archived remittance detail, as well as 1099 information, from the Owner Relations Online System as follows:

- Log on to the Newfield Exploration website ([www.newfield.com](http://www.newfield.com))
- Click on the “Owner Login” at the bottom of the page
- Enter your temporary login name and password (which you received from Oildex) under the Owner Relations Login section
- Complete the new user setup, creating your own login and password, as well as a security questions for future correspondence
- Access your Direct Deposit remittance detail by selecting the Check Detail links

You can view and print the remittance detail and you can elect to have the remittance emailed to you as new payments are processed; both of these options are FREE of charge.

To sign up for Direct Deposit via ACH, complete and return the following form.
